

Temporary residence permit for educational purposes

Major:

A foreign citizen or stateless person (including minors, via a legal representative) who is studying in a public educational institution on a full-time form, Bachelor's, Specialist's, Master's, residency, probation assistantship, internships or training of scientific and scientific-pedagogical personnel in a graduate school (postgraduate studies in a military college) can apply for temporary resident permit for educational purposes (hereinafter - TRPEP).

The TRPEP is issued for the period of study + 180 calendar days after the end of the period of study. The passport is stamped on the issuance of the TRP for educational purposes.

A foreign citizen who has received the TRPEP has the right to apply for a residence permit within 3 years after graduation.

The temporary residence permit is cancelled if the student switches from full-time to part-time studies;

There is no annual notice.

Deadlines:

- the term of state service - **38 working days**;
- to put a mark of the TRPEP in case of replacement of the identity document, which previously had a mark on the TRPEP- **no more than 13 working days**;
- to replace the TRPEP in case of errors - **no more than 3 working days** for adults and no more than **11 working days for minors**;
- It is not allowed to be outside the Russian Federation **for more than 6 months in total during a calendar year** (from January 1 to December 31);

Reasons to reject the application and documents:

- Information that is required to be specified in the application is not specified.
- Invalid information in the application.
- Failure to provide documents required for submission.
- Submission of documents that contain defects, which prevent the full use of the information and data contained in the document.
- Non-compliance or expiration of documents, as well as those submitted on their own initiative.
- Submission of an identity document that is not recognized as such in the Russian Federation.
- Refusal to undergo dactyloscopic registration.

Ways of submitting documents to receive the TRPEP:

- 1) With the help of Federal Unitary Enterprise "PVS" of the Ministry of Internal Affairs of Russia by tel. 8 (812) 703-68-78 (preparation of documents + record ≈ 5500 rubles)
- 2) By yourself at the Department of Internal Affairs of the Ministry of Internal Affairs at 10-12 Krasny Tekstilshchik St., Lit. D, or by phone. 8 (812) 573-16-37

List of documents:

- 1) Application for issuance of the TRPEP in 2 copies (do it yourself or in the "PVS")
- 2) 2 matte photos 35x45 and in light clothes
- 3) Passport + certified translation (all pages must be reflected in the translation. Translation of stamps is not required)
- 4) Migration Card
- 5) Original registration (ask for in the 3423-1 office)
- 6) Visa (for foreign citizens of visa countries)
- 7) Certificate of criminal record with a certified translation - only for those who stay in Russia on a visa basis (The translation must be made in Russia and filed with the original document. Document validity period - 3 months)
- 8) Extract from the enrollment order and certified by the seal of the educational institution (For students from visa countries and those admitted under the direction of the Ministry of Education - office 3418

For all other students - academic dean's office/chancellery).

It is necessary to indicate:

- the form of education - full-time;
- the date of the beginning of education and the end of the study period;
- program of study (bachelor's degree, master's degree, etc.);
- field of study (program code).

9) If paragraph 8 does not contain the above information, it is necessary to request a certificate of education certified by the seal of the educational organization, which contains the missing information.

10) A copy of the certificate of license and state accreditation of the educational program (specialty) - office 3234.

11) A referral from the Ministry of Science and Higher Education of the Russian Federation, which is certified by the seal of the educational organization (for students enrolled by referral from the Ministry of Education - office 3418).

12) Medical documents issued by a medical organization that is authorized to conduct examination of foreign citizens for the purpose of obtaining a residence permit (documents obtained during dactyloscopy procedure are suitable):

- Medical report from an addiction psychiatrist;

- certificate of absence of HIV-infection;
 - Medical certificate on absence of infectious diseases.
- 13) A receipt for the payment of the state fee in the amount of 1600 rubles.
